

Modules Covered in CFP Program



In CFP Final Exam – There is a one case study and from that case study 25 Multiple choice questions will be asked. These 25 questions is from six components of Financial Planning, viz. Risk Management and Insurance Planning, Estate Planning, Investment Planning and Asset Management, Retirement Planning, Tax Planning, and Personal Financial Management.

Fast track Pathway – In Brief

Professionals in Financial services having Specified

- (a) Education Qualification (details given in next slide), and
- (b) Relevant three years work experience

Would be eligible to register, upon verification of their credentials, in the FPSB Integrated Financial Planning course (CFP Final – 4th Level)

Once registered for the IFP (CFP Final – 4th Level) course, every Challenge status pathway candidate shall be at par with a regular candidate and shall follow the same pattern of Education, examination and certification to qualify CFP Final Case study Project & Exam.

- Post Graduate Certificate program in Finance, PGDFM or other equivalent courses offered by IIM
- Fellow member of Insurance Institute of India (LI/GI)


