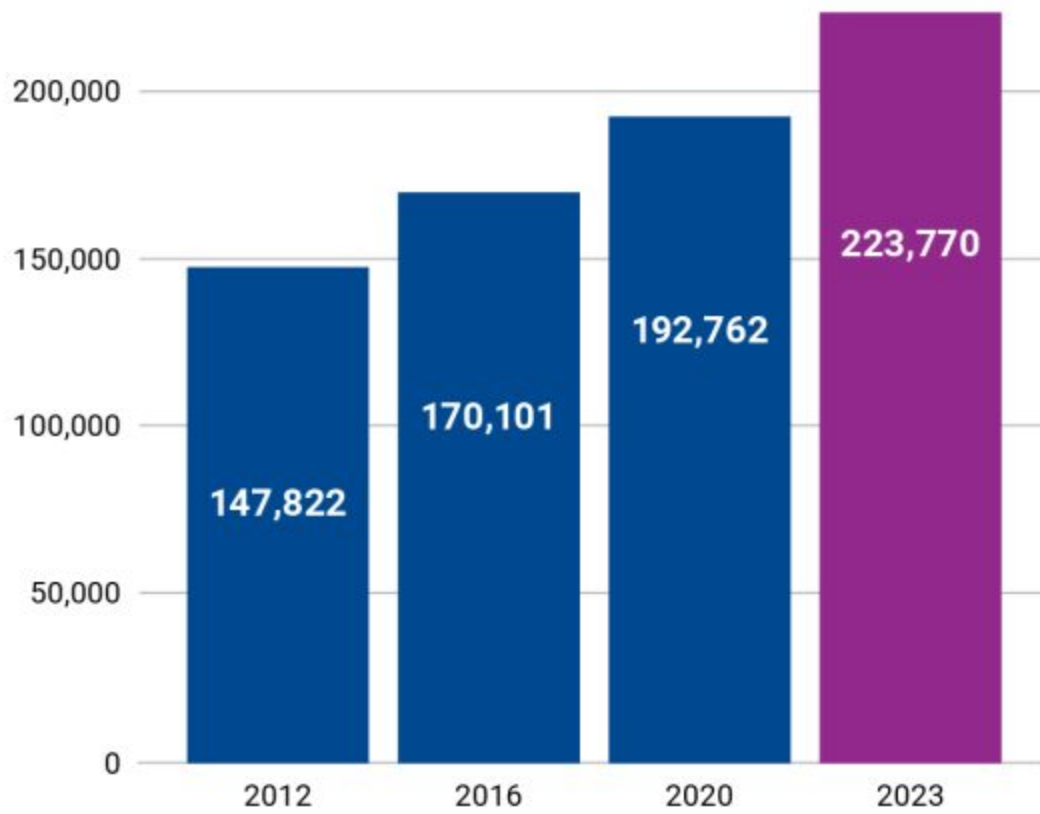

Global Growth of CFP Professionals

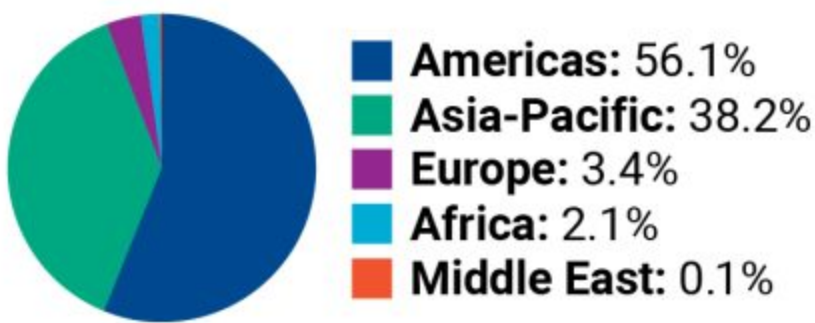

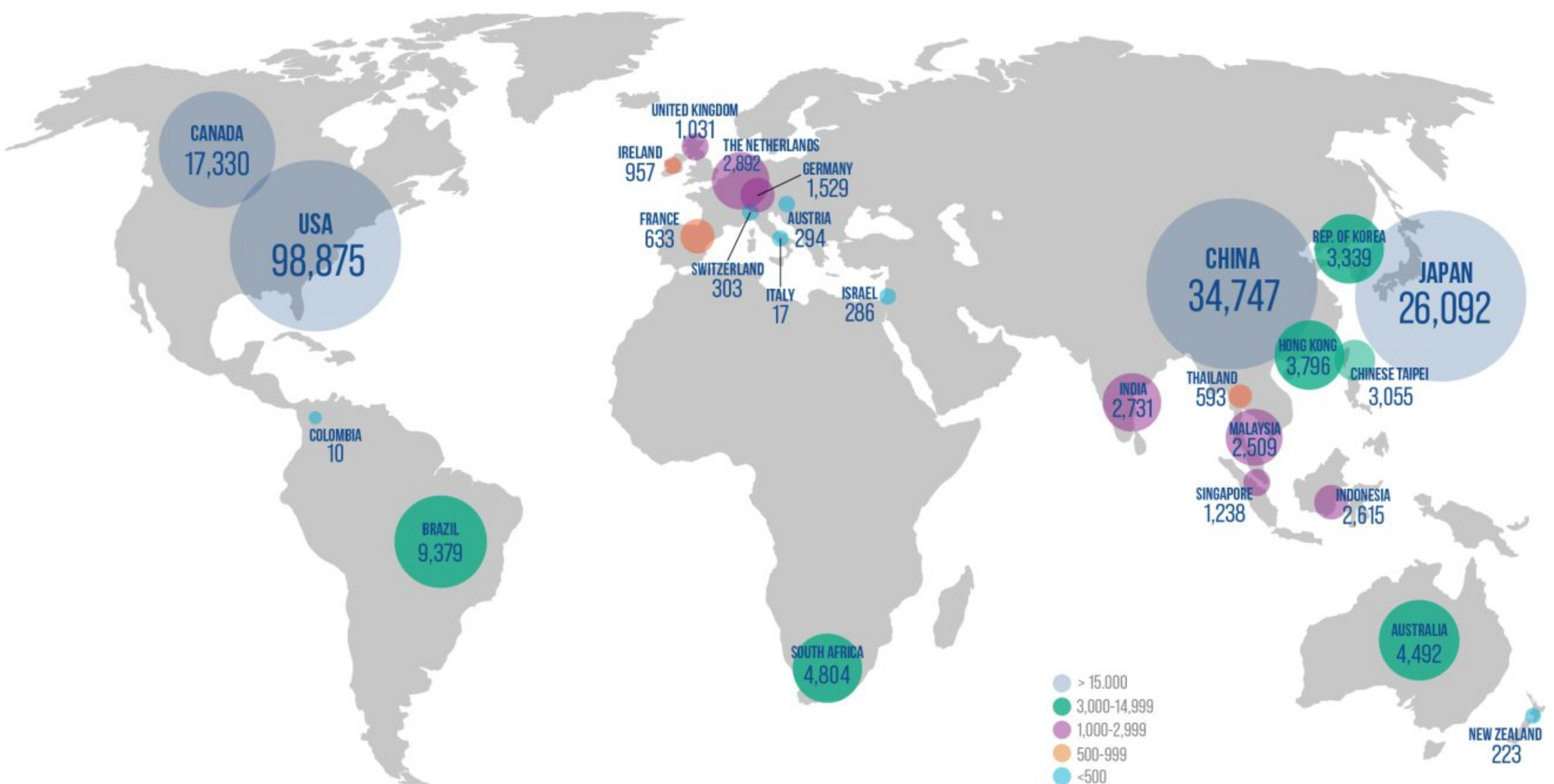
